# **Medication Update**

An FDA review of study findings showed a potential increased risk of heart rhythm problems, called arrhythmias, in patients with heart disease who are taking the seizure mental health medicine and (lamotrigine). Lamictal FDA received reports of abnormal electrocardiographic (ECG) findings and some other problems.

Lamotrigine is used alone or with other medicines to treat seizures in patients 2 years and older. It may also be used as maintenance treatment in patients with bipolar disorder to help delav the occurrence of mood episodes such mania, depression, as or hypomania.

Patients should not stop taking your medicine without first talking to your prescriber because stopping lamotrigine can lead to uncontrolled seizures, or new or worsening mental health problems. Contact your health care professional right away or go

to an emergency room if you experience an abnormal heart rate or irregular rhythm, or symptoms such as a racing heartbeat, skipped or slow heartbeat, shortness of breath. dizziness. or fainting. Source: FDA Medwatch via e-mail ##

#### How Does Genesee County's Mental Health Court Work?

GHS provides an array of Jail Diversion services to the residents of Genesee County, one of which is the Mental Health Court. A GHS social worker screens individuals within the county jail and our prison for mental healthrelated needs. Mental Health Court diverts from jail individuals with mental illness who have been arrested and provides monitoring and treatment for one year. If the person complies, after one year the charges are dropped.

Mental Health Court also provides special court hearings for convicted people with mental illnesses who were not on medication at the time the crime was committed. These inmates are referred to GHS. Mental Health Court will take almost any crime except for sexual offenses or murder.

The social worker meets with each potential participant and completes a screening form. Potential participants are scheduled with the GHS Access Department. If determined eligible, a person is scheduled GHS with intake to begin services. The person will participate in case management services based medical on necessity requirements.

The MH court Case Manager focus is on linking, monitoring, advocating, assessing and

coordinating services with a specific focus on the mental health needs that influenced the person's involvement with the legal system. Some employers work with the Mental Health Court and will hire those in the program. Typically there are 50 to 60 in the program, fewer now because of covid. Source: GHS April 2021 Board minutes

We are fortunate to have an adult mental health court, an adolescent mental health court, a veteran's court, a baby court for young mothers and a sobriety court. These courts require cooperation from the sheriff, prosecutor, judges, public defenders, private lawyers, Genesee Health System and the people who have been arrested. Genesee County is a model for Michigan. #### Research: A Possible Treatment for Alcohol Addiction

Researcher Raymond Anton and colleagues reported in *JAMA Internal Medicine* that compared with placebo, the anticonvulsant gabapentin (Neurontin)helped people with alcohol use disorders reduce their drinking or abstain from drinking in a small study.

Ninety-six people with alcohol addiction took part in the double blind study for 16 weeks. 27% of the people who took gabapentin had no heavy drinking days compared to 9% of the placebo group. 18% achieved total abstinence compared to 4% of the placebo group. Gabapentin appeared to be most effective for people with a history of alcohol withdrawal symptoms. 41% of participants with high alcohol withdrawal symptoms who took gabapentin achieved total abstinence compared with 1% of participants who took the placebo. Gabapentin is used to treat epilepsy and is an add on drug to treat the anxiety of bipolar disorder. Source: *Bipolar Network News*, Vol. 24, Issue 2, 2010 bipolarnews.org. Free subscriptions

# What is CIT and Why Do We Need It?

Ramona Deese, Editor In June of 2013, police responded to a request for a welfare check on a possibly suicidal person with a mental illness in a city in southern Genesee County. They called in back-up from the state police. The officers were armed with assault rifles and tasers. When the man's brother arrived to speak with the suicidal man, police put him in a police car and threatened to arrest him. After a 6 hour stand-off, the suicidal man was and charged with arrested felonious assault.

I was president of NAMI Genesee County at the time and I was horrified at the response of the police and the chief who remarked that since nobody was hurt, their intervention was successful. Later he admitted to a newspaper reporter that maybe his officers did need more training. I had written a letter to the editor pointing out that responding to a mentally ill person with a show of force tends to further upset the person and escalate a situation that might have been avoided if police had received adequate Crisis Intervention Training.

Forward to 2021. A start-up grant to design and implement CIT training in Genesee County was awarded. More than 20 organizations, including law enforcement officials, have been meeting to plan and implement week long, 40 hour training for police, EMTs and mental health professionals this summer. They would learn about mental illness, substance use disorders and deescalation techniques. Responding teams would be formed and psychological first aid would be provided.

Long term goal is to provide training for police officers in all Genesee County jurisdictions as funding becomes available. CIT improves officer, family and consumer safety; decriminalizes mental illness; results in less use of weapons by police; lowers jail costs and gets needed treatment for people with mental illness and substance use disorders. ##
